Black River United Way provided support and funding for Georgetown County School District and Williamsburg County through two major programs:

Growing Great Readers Americorps Program - provides in/out of school reading intervention for elementary schools and afterschool programs; and Summer S.A.I.L. (Summer and Inquiry Learning) - prevents the summer slide of reading for students. In the two programs, 292 Students received reading tutor/intervention support. Of the 292 students served, 116 students were on or above reading grade level. 161 students made significant improvements; getting them closer to reading grade level. 15 students were identified specialized intervention beyond Black River United Way's Volunteer Capacity.

Black River United Way also partnered with the United Way of Horry County in an annual event called United To Read in which 6000 Kindergarten - 2nd Grade students in three counties: Georgetown, Horry and Williamsburg; are read the same book at the same time by over 300 volunteers.

In addition, Black River United Way through partnership with a local foundation, provides Dolly Parton Imagination Library books to kids, birth to 5 years old. In 2018, over 1300 students received 16,163 books.

Black River United Way through the Winyah Bay Long Term Recovery Group renovated 64 homes that were damaged in the Historic Flood and Hurricane Matthew. 22 homes were completed in Georgetown County and 42 homes were completed in Williamsburg County. These homes are now safe, secure and sanitary.

the Internal Revenue Service. It offers free tax help to people who generally make \$55,000 or less, persons with disabilities and limited English speaking taxpayers who need assistance in preparing their own tax returns. Last year the Black River United Way VITA Coalition filed 804 individual/joint tax returns with a total refund of \$1,024,218. This is a savings of over \$200,000 in tax preparation fees. Eligible clients also were able to claim over \$448,000 in the Earned Income Tax Credit and over \$148,000 in Child Tax Credits.

In addition, Black River United Way was able to provide \$99,000 to four non-profits helping eligible clients with rent/mortgage, utility and food through the Emergency Food & Shelter Program grant.

Community Outreach

2-1-1 is an easy to remember, three digit telephone number that connects people with important community services to meet every day needs and the immediate needs of people in crisis. 2-1-1 received 703 person to person calls (409 Georgetown County & 294 Williamsburg County), with 1215 referrals made, connecting people to resources in the community.

FamilyWize Community Service Partnership, Inc. is committed to helping improve people's health by making prescription medications more affordable.

FamilyWize helped 3975 people and saved over \$271,000 in prescription costs in Georgetown and Williamsburg Counties.

Americorps VISTA (Volunteers In Service To America) is a national service program designed to strengthen organizations that help to alleviate poverty. IN 2018, four VISTA's served at four non-profit organizations. They recruited collectively 229 volunteers that served 358 hours and raised over \$19,000 through grants and fundraisers. VISTAs also implemented new programs and processes to expand each nonprofit's reach in community.
